# What is the Education Plan 2026?

- The plan will guide the Board for the next five years
- Roadmap to improve outcomes for students
- VSB wants to hear the expectations and aspirations of the people of Vancouver
- Development of the plan must consider and involve the various audiences affected - students, families, teachers, administrators, employers, post-secondary institutions, education partners and Vancouver residents

#### How can we take part?

- Round one of knowledge gathering: a short online survey
- It asks some specific questions and provides opportunities to comment about anything they think is important for the VSB t consider in developing the plan
- Participants can also upload documents to the survey to provide further detail about their expectations and aspirations for Vancouver schools
- PACs can submit a 'collective voice' document as well as parents individually completing the survey
- Round two of knowledge gathering: later in year once proposed goals and objectives are developed

New Ministry Reporting Order: Opportunity to Provide Input

- Students and parents/guardians/caregivers need to receive regular, clear communication about student learning throughout the school year. To help ensure this information is provided consistently from K-12, the Ministry is replacing three different policies with one, unified K-12 Student Reporting Policy.

This new policy is aligned with the curriculum that was introduced beginning in 2016 and will ensure parents/guardians receive information about:

- student progress in each subject area the student is currently studying,
- areas of significant student growth and opportunities for further development,
  student attendance.
- The policy will also give students a voice in their learning by requiring student selfassessment and goal setting to be included in reports home. In consultation with a diverse range of partners in the education sector, the Ministry of Education has developed a proposed draft of this new policy.
- Then in November 2021, a What We Heard Report summarizing this feedback will be released. The Ministry of Education will then release an updated and final policy in January 2022. Once approved, this final policy is projected to come into effect for the 2022/2023 school year

# FIT = Flexible Instructional Time

- Provides flexible learning environments for all, acknowledging that learning can take place in a variety of places in a variety of ways
- Provides students with choice, voice, and flexibility with their learning in order to independently complete assignments, study, collaborate with peers, complete homework, or engage in a personal area of interest
- Provides the opportunity for students to receive support and guidance from staff
- Supports student time management and organization, by providing an opportunity for students to practice these skills with the guidance of staff

# FIT = Flexible Instructional Time

 Our definition of student choice is informed by the Ministry of Education. "Students benefit from more flexibility and choice of how, when, and where their learning takes place. This will become increasingly important as B.C. takes a more inclusive approach to education, ensuring all students – regardless of ability or background – benefit from a learning environment tailored to maximize their potential." Student choice means students choosing how, when, and where learning takes place.
