Good afternoon,

In advance of the Board meeting agenda being published today, I am writing to let you know that District staff will be presenting a report to the Board on Monday January 17, 2022 recommending the consideration of closure of Queen Elizabeth Annex (QEA) effective July 1, 2023. The report also outlines options for accommodating current and future QEA students, at either Jules Quesnel or Queen Elizabeth Elementary School, should QEA be closed. The report will be posted today on the District's website after 4 pm.

It is important to note that no decision has been made. The earliest the Board would make a the decision to close QEA would be at a Board meeting currently scheduled for May 30, 2022. As per Board Policy 14 – School Closure, a number of steps must be taken prior to the Board deciding to close a school. A graphic describing the consideration of that process is attached to this letter. These steps include:

- 1) Senior District staff must formally submit a report to the Board at a public Board meeting, currently scheduled for January 17, 2022. As per standard practice, all report submissions occur three days prior to a Board meeting to provide trustees with time to review materials.
- 2) If the Board decides to continue the process, further discussions will take place with stakeholders at a Facilities Planning Committee meeting, currently scheduled for January 19, 2022. Based on these discussions, trustee members of the committee will make a recommendation to the Board at the next public Board meeting.
- At next Board meeting, scheduled for January 31, 2022, the Board will consider recommendations from Facilities Planning Committee and decide to either begin an engagement process or stop the closure consideration.
- 4) If the Board votes to begin an engagement process, school communities will have an opportunity to have their voices heard during this engagement phase of the process. Feedback from the engagement will be provided to the Board for their review and consideration in making a closure decision.
- 5) Should the Board proceed with the closure process, it will make a final decision at a public Board meeting, currently scheduled for May 30, 2022.

The committee will provide its recommendation to the Board as to whether to proceed to public engagement. **BOARD MEETING** JAN 31, 2022 The Board reviews the recommendation from the Facilities Planning Committee and decides to: begin an engagement stop the closure process OR process **PUBLIC ENGAGAMENT** WINTER/SPRING 2022 If step 3 is passed, school communities will have an opportunity to provide feedback through an engagement process, which the Board will consider as part of its decision making process. **BOARD'S FINAL DECISION** MAY 30, 2022 The Board will make its final decision at a public Board meeting to: keep the school open OR
