### 1. CALL MEETING TO ORDER

#### **1.1 Indigenous Land Acknowledgement**

The Chairperson called the meeting to order and acknowledged that we are unlearning and relearning on the traditional and unceded lands of the x<sup>w</sup>məθk<sup>w</sup>əỳəm (Musqueam), Skwxwú7mesh (Squamish) and səlilwətał (Tsleil-Waututh) Nations.

The Board Chair informed everyone that the only item on the agenda was the Consideration of Closure of Queen Elizabeth Annex (QEA). She read the motion that was being considered.

#### 2. OLD BUSINESS

2.1 Consideration of Closure of Queen Elizabeth Annex (QEA)

Moved by A. Wong, seconded by E. Gonzalez, that the Board of Education approves the permanent closure of Queen Elizabeth Annex effective June 30, 2023.

Trustees provided rationale and comments on the motion prior to voting.

The motion was defeated as it did not receive unanimous approval. The Secretary Treasurer informed everyone that the third reading of the bylaw would need to take place at another board meeting. Trustee Reddy requested clarification on the process for the bylaw reading, and the Secretary Treasurer responded. He explained that not all three readings need to take place at one meeting; however, if the Board would like to have all three readings at one meeting, then approval for the third reading would need to be unanimous. Trustee Reddy requested an adjustment to her vote.

The Board Chair requested a mover and seconder for the motion to reconsider the vote. She requested that the Secretary Treasurer read the motion again.

Moved by C. Cho, seconded by A. Wong, that the Board of Education reconsider the motion:

That the Board of Education approves having all three readings of the School District No. 39 (Vancouver) Queen Elizabeth Annex School Closure Bylaw 2022 at this June 6, 2022 meeting.
