Overview of ELL Consortium:

The ELL Consortium is an ad hoc committee of the BC School Trustees Association that includes staff from various districts who provide updates and accurate information on what is happening at the municipal, provincial and federal levels in the area of English Language Learners.

Key Topic:

Movement of Settlement funds from Provincial to Federal government in 2014 resulted in: a) change in criteria for settlement services, restricting services for students and families of certain status; b) change in federal schedule of funds misaligning with school-year; c) provincial funds left as minimal; d) impacts on other services including health, employment, education completion, relationships, and stability; e) 3-year average timeline of services with federal funding results in lag of services; f) call-for-proposal (CFP) model as opposed to Grant model; g) tight timelines for 'top up' funds

VSB ELL Students Ineligible for Settlement Workers in Schools (SWIS) Services:

Ineligible students represent between 30% and 50%+ of newcomers in School Districts. Ineligible students under Federal SWIS Funding include: work permit and post-secondary student visa holders, provincial nominees awaiting their permanent residency, refugee claimants, and returning citizens who have settlement needs.

Settlement needs of any ELL student, regardless of status, can go beyond learning English to include:

- status in Canada and Federal/Provincial funding for service levels based on status
- school act that does not limit access to support services
- pathways to post-secondary including adult education
- schools as critical point of contact
- poverty and housing issues, trauma, and gender-based and domestic violence

Committee / Organization Actions:

Invited MPs and MLAs to January 2019 Consortium Meeting:



- 5. Advocate with Boards to reach out to IRCC with letter outlining issue and request (see details below)

Whereas:

As Canada welcomes newcomers to our country, it is difficult to understand why funding to help newcomers with settlement challenges are provided only for "eligible" clients. Those deemed to be "ineligible" are downloaded on to other levels of government without the funding to support programmes needed to help newcomers settle in Canada.

In our public-school system in British Columbia, we support all students and families who walk through our doors. Our goal is to help families settle in to our communities so their children can benefit from the education our system provides. Newcomers come to Canada to make a better life for their families. They want to be productive, contributing members to Canadian society and to pay their way as they are able.

Over the years, the numbers of newcomers, both eligible and ineligible, have increased, however, the funding has not kept up with the rising numbers. The numbers of ineligible clients has risen the most and yet they are not recognized for funding purposes.

• Increased, predictable, stable funding to enable Boards of Education to provide essential support services for immigrant families settling in our communities (BCSTA AGM 2018 motion)

Provincial Government (MLAs)

• Asylum seekers – Ontario, Quebec and Manitoba are receiving funds from a \$50 million federal pot to help with costs. BC has more asylum seekers than Manitoba but receives no funding. BC government to request some of that funding
