Vancouver School District Families,

The Board is currently considering the closure of Queen Elizabeth Annex (QEA) effective June 30, 2023. A final decision has not yet been made by the Board. Currently the Board is seeking public input and feedback through an engagement process. Information received through this process will be considered by the Board in making a decision on the proposed closure at the May 30, 2022 public Board Meeting.

The Annex offers French Immersion programming to Vancouver students in kindergarten to Grade 3. There are 71 students attending QEA. It is the feeder school to Jules Quesnel Elementary (JQ), which offers K to 7 French immersion programming. As a District choice program, the Annex does not have a neighbourhood catchment, rather it enrolls students from across the District.

Should the Board decide to close QEA, staff propose students be relocated, as a group, at either Jules Quesnel Elementary or Queen Elizabeth Elementary. Other possible sites, identified through the engagement process, may also be considered.
