"The Vancouver DPAC represents the collective voice of parents and caregivers in Vancouver public schools. We are dedicated to supporting parent engagement, fostering communication between families and the Vancouver School Board (VSB), and advocating for equitable education opportunities for all students.

Advocacy – We amplify parent and caregiver voices on education policies for the benefit of students and school communities

Representation – We represent collective views at the district level

Support – We provide resources, training and guidance to Parent Advisory Councils

Events and Workshops – We host guest speakers, forums, and informational sessions"

What Is the role of the DPAC Rep?

I attend monthly DPAC general meetings virtually and report back to the DLG community through the DLG PAC. If there is a vote at the general meeting, I represent DLG. **All parents and caregivers are welcome to attend the DPAC General Meetings**; however, only the DPAC rep votes.

Yes! I've attended two meetings so far – September and October. The general meetings are at 7pm on the third Thursdays of each month. Here are some of the highlights and associated resources that you may find interesting or helpful:

Cathie McMillain from Dyslexia BC. Presented at the October meeting in recognition of Dyslexia Awareness Month. She spoke about her experiences parenting children with dyslexia and discovering that she herself is dyslexic – as an adult. She spoke about the new K-12 Provincial Learning Strategy.
