Personal Information Directory

The Vancouver School Board is subject to the Freedom of Information and Protection of Privacy Act ("FIPPA"), which governs the collection, use, disclosure, and protection of personal information. As part of its commitment to accountability, transparency, and privacy, the District provides public access to an inventory – known as a Personal Information Directory (PID) – that outlines the different collections of personal information it maintains, referred to as personal information banks.

The development of a PID is mandated under Section 69(6) of FIPPA, which requires the creation of a directory listing all personal information banks held by the District. In addition, FIPPA specifies that the PID must include detailed information about each personal information bank, including:

- Title and location of the personal information bank.
- Description of the type of personal information and the categories of individuals whose information is included;
- The legal authority for collecting the personal information;
- The purposes for which the personal information is collected or compiled, and the purposes for which it is used or may be disclosed; and
- The categories of people who use the personal information or to whom it is or may be disclosed.

PIB Location: Lists the physical and/or electronic site(s) where the

PIB is kept and accessed.

Individuals included in the

PIB:

Lists the categories of individuals (described in general

terms), of which the information in the PIB pertains.

Type(s) of Personal

Information:

Describes the main categories of types of personal information collected and maintained within the PIB.

Users: Lists the categories of persons who use the personal

information or whom it is disclosed.

Purpose: States the reasoning for the collection, use, and/or

disclosure of the personal information held within the

PIB.

Legal Authority: Lists the provincial statutes that govern the collection,

use, disclosure, retention, and disposition of the personal information maintained in the PIB.
