Thank you for the opportunity to provide input into the VSB budget. I filled out a survey, but was disappointed by both the way questions were asked, and for not having a specific area to provide further comment on why I answered questions in the way I did.

I found the paragraph descriptions of the question topics to be very vague and used a lot of loaded terms that could mean drastic changes, such as staffing cuts or facility closures, yet the questions were asked in a way that masked any specific actions that could be considered. I am supportive of being efficient, but not at the expense of having sufficient good quality staff that should be paid well, adequate programs for students who want to take them, and well-maintained facilities. Current funding for schools in Vancouver is inadequate- all students should have access to dedicated physical education AND music education teachers. All students should have adequately maintained facilities. All students should have a neighbourhood school.

More funding should be provided to VSB through higher tax rates of city residents, particularly high-wealth households.

Hello there, I saw your survey online and tried to complete it but the questions were so vague that I saw no way to answer it in a way that conveys my actual priorities as a taxpayer and former student in BC. Of course we all want our education system to be more efficient, equitable, and high-quality - no one in their right mind would disagree with that. How we might best achieve that is the real question.

For myself, I have no problem with the school board running deficits if it means that students, school staff, and communities in general are supported and well-resourced. Public education is not a for-profit corporation; it has no real independent revenue of its own; it's a public good whose positive impact is immeasurable, and if VSB doesn't have enough funding to adequately serve the public given all of the financial pressures of recent years, then the province needs to fill the gap. I'm happy to pay a bit more in tax if it means students of all ages and abilities have access to education in all its forms - including arts, culture, languages, sports, trades, special programs, hiring programs, night school, libraries, clubs, guidance/career counselling, etc. Every student deserves to have a school close by, with class sizes small enough that their teachers can properly support them, and options available to address whatever challenges they may run into.

Running deficits (and even borrowing money) shows the province that VSB needs more funding; if you simply cut services, staff, or facilities instead, then students will suffer, and the province will have an argument to keep underfunding since "the budget is balanced". Don't play into their hands - if VSB values its own mission, then it shouldn't compromise on that mission just to avoid accusations of "fiscal irresponsibility" from people who don't understand how government funding or our education system works. If VSB is transparent and vocal about its need for increased funding from the province/taxpayers, then no one can fault it for running deficits while it's waiting and pushing for real action from other levels of government.
