1. CALL MEETING TO ORDER

1.1 Indigenous Land Acknowledgement

The Chairperson called the meeting to order and acknowledged that we are unlearning and relearning on the traditional and unceded lands of the $x^wm \ni \theta k^w \ni \dot{\gamma} \ni m$ (Musqueam), $S\underline{k}w\underline{x}w\dot{u}$ 7mesh (Squamish) and $s\ni llw\ni ta^{\frac{1}{2}}$ (Tsleil-Waututh) Nations.

The Chairperson informed everyone the meeting is being live-streamed and the audio and visual recording will also be available to the public for viewing after the meeting. The footage of the meeting may be viewed inside and outside of Canada. She reviewed meeting decorum for respectful behavior.

1.2 Opening Remarks

In her opening remarks, the Chairperson acknowledged the following:

- The current global issue in Ukraine and prioritizing the mental health and well-being of students, families, and staff at this time.
- Black History Month, providing examples of how the Vancouver School Board (VSB) has celebrated Black History and Excellence.
- Recognition days, including Pink Shirt Day, Family Day, Lunar New Year Celebrations, and Valentine's Day.

- March 3rd virtual keynote session featuring Dr. Gholdy Muhammad, writer of the book Cultivating Genius – An Equity Framework for Culturally and Historically Responsive Literacy.
- The VSB Education Plan and next steps.

2. PROGRAM HIGHLIGHTS

2.1 VSBean Coffee Cart

The Director of Instruction, Learning Services, R. Poetschke and the District Resource Teacher, P. Neuman presented the Program Highlight, entitled VSBean Coffee Cart. Ms. Neuman provided background on the coffee cart as a unique work experience for secondary special education students. She presented a video which featured students from the secondary special education program at Garibaldi Annex and students from the Tupper Tech Class, who helped build the cart. In the video, students John Gaor, Georgia Wootton, Andrei Ibaan, Yianni Papastamatiou, and Michael Coleman-Hughes spoke about their experiences working at the coffee cart.

4. SUPERINTENDENT'S UPDATE

The Superintendent gave a PowerPoint presentation, entitled Superintendent's Highlights, a copy of which is on file with the meeting agenda.

In highlighting the District's work on diversity, the Superintendent introduced VSB Farsi settlement worker, Soheila Ansari, in Teams. Ms. Ansari provided information about her role in supporting students and



families in adjusting to living in Canada. The presentation also included shared experiences from Sahar Aghazadeh, a grade 12 King George student, and Sodeh Fazeli, a VSB parent.

The Superintendent continued her presentation by providing an overview of her work in February, including establishing connections with stakeholders, and Members of the Legislative Assembly (MLA)s. She reviewed the District highlights for February, including District Professional Development Day, Black History Month, and an update on the Education Plan.

She concluded her presentation with an update on COVID-19, which included information on Rapid Antigen test kit distribution for students and staff, informing that there have not been any new public health notices and there have been no functional closures across VSB schools. The Superintendent also commented on the work of the communicable disease prevention plan, and resumption of sports activities. She indicated future COVID-19 updates from her would only come forward if there were new developments with the pandemic as part of the Superintendent's Highlights.
