- ✓ Seek help from "Digital Guides" (classmates with technological experience)
- ✓ Respect online sites and materials
- ✓ Respect my own and others' privacy never reveal addresses, phone numbers, or pictures online

Digital Responsibility Home Contract

Access to technology is growing in importance for supporting and enhancing students' learning. To enable more regular access to technology for learning, our school encourages students who have their own technology, to bring it to school to use as part of their learning. It is essential that parents or guardians join with us in providing a safe and productive environment for students to use their technology. Before your child can bring their own technology to school, we require your commitment to the following important practices to manage your child's home use of technology.

Parental/Guardian Commitments

I understand that it is important to:

- ✓ Keep the technology my child uses in a central and visible location
- ✓ Regularly monitor my child's Internet browser history
- ✓ Monitor my child's 'screen time' in the evenings and after school (a suggested practice: 1 hour per night and 2 hours on weekends; https://www.commonsensemedia.org/screen-time/how-much-screen-time-is-ok-for-my-kids)
- Educate myself about what my child is doing with their technology and be aware of who they are communicating with
- ✓ Limit my child's use of social media until they are 13 years old as required by social media terms of service
- ✓ Monitor and guide my child's conversations using technology (messaging, posting, emailing, texting) for kind and respectful language and behavior
- ✓ Be aware of and ask my child questions about suspicious behavior such as my child switching applications or turning off their technology when adults approach them

I understand the consequences for my child if they use their technology in unacceptable ways and will:

✓ Suspend my child's use of their technology and inform my child's teacher by sending a note to school
