We are pleased to have made significant progress on this issue, working in partnership with the provincial government, but we still have many schools to complete by the province's goal of all schools being completed by 2020. We believe that by working together we can accelerate the pace of school upgrades or replacements to ensure all students are in safe buildings by 2020.

We also continue to struggle financially as in every year but one in the last dozen, funding levels have not kept pace with the combined costs of salary, benefit and pension contribution increases, inflation, and additional costs to school boards (carbon offsets, insurance premiums, MSP increases etc). Our finance department calculates that after adjusting for enrolment declines and inflation, it would take almost \$50 million a year in increased operating funds to support equivalent staffing, service and resource levels for students as we did 12 years ago.

We know many of our families continue to struggle with poverty and access to quality affordable childcare, placing additional pressure on schools and affecting students' ability to learn. We also face challenging class composition issues as the percentage of students assessed with special learning needs continues to increase in relation to overall enrolment.

We are pleased to report some progress on improved outcomes for Aboriginal students, but we have much work to do to ensure improved outcomes and opportunities for all students.

Our Board would appreciate an opportunity to meet with you to tell you more about the Vancouver school district, so we can share both our successes and our challenges.
